

## SCHEMA ST4 - Terms of use ST4 Smart Extensions [2023-08]

### Technical Basics and Terms of Use

#### Initial situation

Licensee has entered into a software license agreement with Quanos and, on this basis, has acquired one or more licenses to the SCHEMA ST4 computer program and has installed this computer program on its premises.

#### Compatibility

Quanos guarantees compatibility of an ST4 Smart Extension only for explicitly designated versions of SCHEMA ST4. Compatibility may exist for newer or older versions, but it is not guaranteed. Correct functioning is also not ensured if the customer uses a modeling and special data structures that differ from the initial configuration. Given that an ST4 Smart Extension is not part of the SCHEMA ST4 computer program, Product Support also does not provide any support for installation or handling.

#### Terms of Use

In addition, Quanos offers the Licensee one or more ST4 Smart Extensions. An ST4 Smart Extension is an independent product in the form of a bundled setting of various parameters of the SCHEMA ST4 computer program. An ST4 Smart Extension is thus a parameterization that, for example, enables the automation of workflows or adds new, self-contained functions. For this purpose, an ST4 Smart Extension is built on top of existing tools (Page Layout Designer, Automation Designer) or scripting interfaces.

ST4 Smart Extensions can be utilized only if the Licensee uses the standard configuration of the SCHEMA ST4 computer program.

The development and use of ST4 Smart Extensions does not result in a change of the source code of the SCHEMA ST4 computer program, which means that ST4 Smart Extensions are neither an update nor an upgrade.

Quanos grants the Licensee a right to use the ST4 Smart Extension product in accordance with the following provisions. This is a simple right of use that is unlimited in terms of time and location.

The Licensee may use ST4 Smart Extensions exclusively in connection with the utilization of the SCHEMA ST4 computer program that is licensed by Licensee.

Commercial utilization of ST4 Smart Extensions by third parties is excluded.

In return for licensing an ST4 Smart Extension, the Licensee remits the fee agreed upon with Quanos.

Quanos creates ST4 Smart Extensions in the form of a data package and sends it to the Licensee (e.g. by e-mail). The Licensee imports this data package into the SCHEMA ST4 computer program via the existing import function.

Quanos guarantees the compatibility of an ST4 Smart Extension only for the version of SCHEMA ST4 that is current at the time of the conclusion of the contract. Quanos does not guarantee compatibility of ST4 Smart Extensions with previous or future versions of SCHEMA ST4.

Apart from that, the warranty of quality and title agreed upon for the software license agreement for the SCHEMA ST4 computer program shall apply accordingly to the utilization of ST4 Smart Extensions.

This Agreement shall be governed exclusively by German law (excluding the rules of conflict of laws).

The exclusive place of jurisdiction for all disputes, if any, in connection with the conclusion and interpretation of this Agreement and the obligations arising therefrom shall be Nuremberg, Germany.

The ST4 Smart Extensions may require Automation Modules, which must be licensed separately. The required modules are listed in the description of the respective ST4 Smart Extension. The prices listed for the ST4 Smart Extensions do not include any licenses.
